I respectfully beg leave further to state
to your Excellency, that whereas many persons
are located by Colonel Talbot ^{who} have obtained
any order in Council for a grant of Land
to cover the assignment made to them by
that Gentleman, it is not in my power
(where the same name occurs in the present
Instance) to determine whether it is the
same person who has already received Lands
in this Province, a difficulty, stated by me
on the 20th of August 1817, in my letter to the
Clerk of the Council

It is therefore respectfully submitted
to your Excellency, that in future, all persons
Applying for Land, whether under Colonel
Talbot's recommendation or otherwise, do
state fully in their Petitions, their address
or profession, place of birth, & from whence,
their age, and period of residence in the
Province, and whether they have ever received
any
