

In August 1835 by an order
in Council of that month upon
the application of Mr Johnson
a sale was authorized to him
upon his acquiescing to release
in the said lot of one Donald
McConnell who purchased the
same for areas of lots under
the assessment act of 1830.

It now appears that Donald
McConnell has conveyed to
Samuel McGill who has conveyed
to Hector Russell whose interest
Johnson is unable to purchase
and that Johnson is not
in a position to comply with
the terms of the order in Council
of 1835.

It is recommended by
the Department of Crown
Lands that repayment
of the sum paid by McConnell
to McGill (3-12-6) and
interest Johnson be allowed
to purchase

Before acceding to this proposition it is necessary to examine the legal rights of the parties. Payment of £312.6 interest if Russell has a legal right to a patent may not be at all an adequate compensation for that right.

It appears that the land was sold in 1830 by the Sheriff for taxes and that the sale took place under Stat 59 Geo III cap 7 but that at the time of sale though the land on the Government map was marked "D" signifying that it had been described for patent no description for patent had in fact issued and consequently that no patent had been granted.

Though land which was not denuded by the surveyor general was not under 59 Geo III liable to be sold for taxes (see d. Bell v. Carr. 8 Hare 519 James, 1.) yet lands described as granted were liable though no patent in fact issued (see d. Mc Lellan v. McDonald B. case, 2) Such appears to be the position of lot 29 in 1 con Plouffe's when sold to Russell.

But it further appears from the Report of the Crown Lands Department dated 30th May 1855 that "in the original Schedule under the Assessment Act prepared in the year 1850 it (the lot) was inserted as under location only"

This completely alters the case. Lands though subjected to assessment when "described in the said Schedule as having been granted or let to lease by His Majesty" is not so when described as "under location only" (59 Geo III cap 7 s. 13)

Assuming the facts stated in the Report of the Commissioners of Crown Lands to be true I have no difficulty in recommending that upon Sir John's paying into the Crown Lands Department the amount for which the lot was sold by the Sheriff together with interest from the date of sale a patent should issue to him - or rather in the words of the recommendation of the Commissioners of Crown Lands "a sale be authorized"

By an order in Council of the 12th Aug - 1855 it was, on Petition of William Johnson who purchased the interest of Peter Blouin, allowed upon improvements on lot No. 29 in the Broken Front & northern part of lot No. 29 in the 1st concession of Plantagenet directed; that on the Petition requiring the interests in the said lot of improvements McDonald was purchased for arrears of taxes in 1831 & a special sale be made in his favor at the rate of seven shillings & six pence per acre. 
