 Master of the High Court of the Admiralty of Cornwall
 lawfully constituted in the sum of two hundred pounds
 of good and lawfull Money of Great Britain to be
 paid unto the said John Hood or to his
 certain Attorney his Executors Administrators or Assigns To which
 payment well and truly to be made Wee Oblige our selves and
 each of us by him self & his selfe for the whole our and
 each of our heirs Executors and Administrators
 firmly by these presents Sealed with our Seals dated the
 15th day of November in the 1st year
 Year of the Reign of our Sovereign Lord Geo: 3^d by the Grace
 of God of Great Britain France and Ireland King Defender of
 the Faith and so forth And in the year of our Lord One thousand
 Seven hundred and Forty two.



The Condition of this Obligation is such that if the above bounden Francis
 Keane of widow Administrators of all and singular the goods Chattells
 and credits of our John Keane late of the parish of Lupatyan Deceased do
 make or cause to be made a true and perfect Inventory of all and singular the Goods Chattells and
 credits of the said deceased which have or shall come to the hands possession or knowledge of her
 the said Francis Keane or into the hands and possession of any
 person or persons for and the same so made do exhibit or cause to be exhibited into the Registry
 of the Admiralty of Cornwall at or before the last day of
 February next ensuing and the same goods chattells and credits and all other the goods
 Chattells and credits of the said Deceased at the time of his death which at any time after shall come
 to the hands or possession of the said Francis Keane or into the hands and
 possession of any other person or persons for her do well and truly administer according to
 law And further do make or cause to be made a true and Just account of her said Administra-
 tion at or before the last day of July next and all the rest and
 residue of the said Goods Chattells and credits which shall be found remaining upon the said
 Administrators account the same being first Examined and allowed of by the Judge or Judges for
 the time being of the said Court shall deliver and pay unto such person or persons respectively as the
 said Judge or Judges by his or their decree or Sentence pursuant to the true intent and meaning of a
 late Act of Parliament made in the two and twentieth and three and twentieth years of the reign
 of our late Sovereign Lord King Charles the Second Intituled An Act for the better settling
 of Intestates Estates shall limit and appoint And if it shall hereafter appear that any last Will
 and Testament was made by the said deceased and the Executor or Executors therein named
 do exhibit the same into the said Court making request to have it allowed and approved accor-
 ding to the said Francis Keane above bounden being thereunto required do rend
 and deliver the said Letters of Administration (appreciation of such Testament being first had
 and made) in the said Court then this Obligation to be void or Else to remain in full force and Virtue
