 land or order for land from the Crown: Your Petitioner, therefore, prays that your ~~Ex~~  
*Honor* ~~will~~ be pleased to grant *her* two hundred acres of the waste lands of  
 the Crown and permit *Isaac Brown Esq* to locate the  
 same and take out the Deed when completed. And as in duty bound will ever pray,
