Know all Men by these presents, that Leah Lake of the Township of Rushby in Keweenaw County in the State of New York one of the United States of America, formerly of the Township of Forest Town in the Midland District and Province of Upper Canada, Widow for and in Consideration of the sum of one hundred pounds of lawful Money by Jacob Comer the younger of the said Township of Forest Town Yeoman, at and before the sealing and delivery of these presents her Receipt bearing date hereby she acknowledges, she granted, assigned, sold, assigned and set over, and by these presents do Grant, bargain, sell, assign and set over unto

the said Jacob Comer the younger, his Executors, Administrators or assigns the annexed written Indenture of Mortgage and the Condition therein and the Interest due and to grow due for the same, and all right title Interest claim and demand whatsoever, in and to the same and every part and parcel thereof with the appurtenances to have and to hold the said premises therein mentioned and described and every part and parcel thereof with the appurtenances unto the said Jacob Comer the younger, his Executors, Administrators and assigns, their heirs and assigns forever, and I do here by authorize the said Jacob Comer the younger in my name to Demand sue for, have hold and enjoy the said sum of one hundred pounds and Interest to his own Use for Ever

In witness whereof I have hereunto set my hand and seal the tenth day of July in the year of our Lord one thousand eight hundred and thirty eight signed sealed and delivered in presence of Leah Lake, the said Leah Lake who made her mark in my presence
